Kernes Adaptive Aquatics Scholarship Policies

Kernes Pool is a nonprofit organization funded by client fees, donations, and grants from local foundations. We are not able to bill insurance companies, government agencies, Medicare, or Medical. Although our goal is to provide services to all who need them, scholarships are awarded only as funding is available.

Scholarship assistance is based on client monthly income and Kernes' financial and staffing resources. Everyone who receives scholarship assistance is asked to consider paying some portion of his or her fees to help Kernes Pool. All clients are requested to fill out a Program Evaluation Form to let us and our funders know how well Kernes is doing.

Scholarship recipients must re-apply and be re-qualified each year according to current fees, changes in client financial status, or changes in available scholarship funding. Full and partial scholarships are awarded for one session per week. Additional sessions are paid by the client unless further funding is available.

Scholarship assistance is assessed by the Executive Director from basic financial and household information provided by the client or family. A completed scholarship request form is required from the client. General guidelines for scholarships are based on national poverty levels. However, an interview may be conducted by the Executive Director to determine eligibility due to financial hardship.

Scholarship recipients must attend 80% of their scheduled sessions to retain scholarship status. Every accommodation will be made to preserve a client's scholarship status and preferred schedule for doctor-excused absences.

Cancellations and Make-up Sessions

- Missed scholarship sessions funded by Kernes cannot be rescheduled.
- Missed sessions paid for by the client can be rescheduled.
- Make up sessions are only allowed with a 24 hour advanced cancellation, and must be completed within 30 days of the missed session(s).
- Kernes reserves the right to cancel a client's scholarship if attendance does not meet the 80% requirement; for inappropriate conduct toward other clients or staff; or if funding or staffing are unavailable.
